# President's Dr. David Potter

t is with severely mixed emotions that I conclude my last commentary to you as president of Delta State. The board's call to become Commissioner of Higher Education was one I felt obliged to accept. The confidence they placed in me, and the honor accorded me, were powerful incentives. The opportunity to try to make a difference on behalf of all our institutions of higher learning is compelling. These

are challenging times for our system, compounded by financial difficulties in the state over the last several years. We have lost and continue to lose good people, including the current commissioner. Those of us who remain have a responsibility to do whatever we can to turn this situation around and to secure a brighter future for our institutions, our students and our alumni.

We do see signs of hope. Thanks in part to the work of the Inter-Alumni Council, the legislature and executive officials recognize our plight and are working hard during this legislative session to reverse the decline of state support for higher education. Our voices, including yours, are being heard, and our persistent articulation of concerns has had an

impact on politicians. I urge each of you, and the Council, to continue to keep our case in front of these officials, so that they will know the urgency and determination we share.

Mixed with the enthusiasm I have for taking on the responsibility of commissioner is the deep regret I feel at having to leave the presidency of Delta State. This presidency is a wonderful job, a privilege. One could not ask for more than to serve an institution with dedicated faculty and staff, enjoyable students, and strong alumni and community support. More than that, this is a place rich with tradition, with energy and vitality, and with caring people who live by humane values. Pam and I have been the beneficiaries of this caring and humanity in ways that have deeply affected us personally and professionally. Delta State and Cleveland have a permanent place in our hearts and our souls. The friendships we have developed here will be ours for a lifetime. We will now count ourselves "alumni" and, in doing so, share many of the feelings you no doubt have for this University.

We pledge to work with the board to secure strong and dedicated new leadership for this University. We will seek a person who understands and appreciates the heritage we share, who is capable and committed to carry forward the work we have begun to enhance the university's future, and who will work collaboratively with all our constituencies to fulfill the spirit of Delta State.

Pam and I thank you all for your support and encouragement during our too brief time here.

Secretary of Defense Donald Rumsfeld recently announced that the President of the United States has nominated former Delta State graduate, Marine Corps Brig. General Thomas L. Moore, Jr., for appointment to the rank of Major General.

Brig. Gen. Moore serves as the principal advisor to the commander of U.S. Joint Forces Command (USJFCOM), Norfolk, Va. on all operational matters that affect the command, and control of assigned U.S. military forces worldwide. He and his staff direct, plan, coordinate, schedule, and control the joint operations and inter-theater deployments of all USJFCOM forces.

Moore's directorate serves as the

command nerve center for providing joint force support. They work closely with other unified commanders to ensure appropriate forces are ready to respond anytime, anywhere in the world. The directorate coordinates forces for combat and peacekeeping operations, humanitarian assistance and also U.S. military support to civil authorities and domestic disaster response like wildfire control.

Moore completed Marine Officer Candidate School in 1973 and was designated a naval aviator in 1975. A career helicopter pilot, Brig. Gen. Moore has been deployed eight times, including to the Persian Gulf for Desert Shield and Desert Storm, where he flew combat operations in and around the Kuwaiti theater. He also has served in a variety of command positions, including commanding officer of more than 2,000 Marines and sailors of the 11th Marine Expeditionary Unit at Camp Pendleton, California.

Brig. Gen. Moore, a native of Scott, and a 1982 graduate, was commissioned as a second lieutenant in 1973 after attending Officer Candidate School in Quantico, Virginia. He graduated from Armed Forces Staff College in 1985 and Air War College at Maxwell AFB, Alabama, in 1994. In 1996, he received his master's degree in human resources management from Troy State University.

His decorations include the Legion of Merit, Defense Meritorious Service Medal, two awards of the Meritorious Service Medal, the Air Medal and the Navy

# Abney to head UPS international

Ronald G. Wallace, a long-time executive of UPS, has announced his retirement and will be succeeded by David P. Abney, who has

helped guide the evolution of UPS's global supply chain management business. Abney, a 1976 graduate, began his new position on January 1, 2003. In leading International package operations, he

will join UPS's Management Committee, which includes the company's 11 most senior executives.

Abney has helped implement new business lines that UPS considers the foundation for its future growth. In 1999, he assumed responsibility for UPS SonicAir, the same-day delivery arm of UPS. Following that,




Abney launched UPS's Service Parts Logistics, the unit that designs and manages urgent parts network and return-and-repair

> operations for customers worldwide. In 2001, Abney oversaw the integration of UPS's largest acquisition of recent years, the Fritz Companies, which has extensive operations in Asia, Europe, and Latin America. He has since played a major role in operating UPS Supply Chain Solutions.

Abney began his UPS career in 1974 as a part-time employee loading and unloading packages in Mississippi. He rose through the ranks in a variety of operational posts, serving as a division manager in New Jersey and district manager in Utah.

Abney has served on the Board of Directors of the Air Couriers Conference of America (ACCA), including a term as co-chairman, and also as the chairman of the Airline Liaison Committee. He currently sits on the board of Cargo Network Services (CNS), a subsidiary of the International Air Transport Association.

## **DSU Provost named interim President**

The Provost and Vice President for Academic Affairs, Dr. John G. Thornell, was recently named Interim President of DSU, by the Board of Trustees of State Institutions of Higher Learning (IHL).

In making the recommendation to the Board to name Dr. Thornell Interim President, Commissioner of Higher Education, Tom Lavzell, described his qualifications, "Dr. Thornell is eminently qualified for the Interim Presidency at DSU. His distinguished career in higher education, especially his administrative experience, will serve him very well at DSU. He will be a strong leader for DSU during this transition," said Layzell. Bryce Griffis, President of the Board, announced the Board's decision to appoint Dr. Thornell: "The Board is very proud to name Dr. John G. Thornell as Interim President at DSU. He brings outstanding experience and credibility to the position. We look forward to working with him," said Griffis.

In accepting the position, Dr. Thornell said, "I am honored and delighted to serve as Interim President of DSU. Education is very important to our citizenry, especially in the Delta. My experience at DSU has served me very well professionally and personally. I welcome the challenge this opportunity presents for service to our state," said Thornell.

Dr. Thornell is a native of Cleveland. He earned a baccalaureate degree in education from DSU in 1969 and taught in the public schools of Greenville, for three years, also earning a Master's degree in Educational Administration from DSU during that time. He completed a Ph.D. in Curriculum and Instruction from the University of Texas in 1974 and accepted a faculty appointment at DSU in 1975. In

1979, he was appointed Director of Institutional Research. In that position he had responsibility for institutional effectiveness, grants, faculty development and faculty research, as well as institutional research.


He spent the summer of 1983 doing postdoctoral work in higher education administration at the University of Michigan. In 1986, he was awarded a Kellogg Fellowship, a program of leadership study and self-development. As part of that fellowship he studied the history and politics of the Soviet Union, traveling there twice for study and also completing a Master's degree in history at Delta State. In 1989, he was named Dean of Graduate Studies and Research at Delta State. In the summer of 1992, he did additional study in Asian history at the University of Tennessee at Chattanooga. He

directed a study tour of Japan in 1993 and transferred his faculty appointment to history.

In 1999, he was promoted to Associate Vice President for Academic Affairs. In that position he was responsible for academic policy development and campus-wide initiatives which supported an expansion of the University's mission, including collaboration with state and federal agencies, business and industry, and other colleges and universities. He was named Vice President for Academic Affairs in 2001 and Provost in 2002.

While at Delta State he has received several awards: Most recently he was named educator of the year for Delta State by the Mississippi Humanities Council. He also has authored or co-authored over \$3 million in grants. His publication record includes over forty articles, book chapters, and professional papers. His current research interests relate to historical studies of the Mississippi Delta, most notably the ethnic groups of the Delta. He also recently completed an oral history of the Chinese in the Delta funded by the Mississippi Humanities Council as well as articles on educational and legal issues facing the early Chinese. He has an active record of community and professional service, having served in a leadership role in numerous organizations. He currently serves on the Board of Directors of the Mississippi Humanities Council and the Mississippi University Press. Dr. Thornell and his wife, Nita, live in Cleveland and have one daughter, Abby, who lives in Orlando, Florida.

Dr. House received her Ph.D. in Administration and Supervision from the University of Mississippi in 1993, a M.A. in Reading Education from Furman University in 1976, and a B.A. in English Education from the University of New Orleans in 1974.

She brings with her a vast knowledge of educational experiences. These experiences include two years as Bureau Director for the Office of Innovative Support with the Mississippi Department of Education. She has been an Associate Professor for Barry University in Miami, Florida, and Delta State, as well as an Adjunct Professor at the University of Mississippi. She has also served as a central office coordinator, principal and teacher in Mississippi's public schools and as Coordinator of Academic Affairs at the Mississippi School of Mathematics and Science in Columbus.

In addition, Dr. House was



selected as one of two IHL representatives to serve on the Mississippi Task Force for Administrator Preparation and Certification. She has worked as a consultant with several school districts on curriculum development/integra-

tion and technology infusion. Dr. House has served as a trained assessor for the NASSP Principals Assessment Center and the Mississippi Principals Development Center and has conducted over 200 workshops for professional organizations and school districts on various topics.

She has been granted certification in Elementary K-8, Reading K-12, English 7-12, Supervision K-12, Administration K-12, and Library Science. Dr. House is a member of the Association of Supervision and Curriculum Development, Kappa Delta Phi, Phi Delta Kappa, and Phi Kappa Phi.

Clarksdale has many tourist attractions and events such as the Delta Blues Museum, Hopson Plantation Commissary, and the annual Tennessee Williams Festival, but lacked accommodations that the six bedroom Belle Clark Bed and Breakfast will now provide.

### McCaslin nominated for Pulitzer

Dr. Richard B. McCaslin, professor of history at High Point University, in High Point, North Carolina, has been nominated the



Pulitzer Prize for his book, *Lee in the Shadow of Washington*. In this book, McCaslin elaborates his thesis that George

Washington served as Robert E. Lee's model for every important decision Lee made in life.

"When faced with crucial decisions, such as the secession crisis, Lee looked to the example of Washington for guidance," McCaslin said. "It was the great disappointment of his life when he failed as a revolutionary commander."

McCaslin is a Civil War specialist and author of 12 books, including *Tainted Breeze: The Great Hanging at Gainsville, Texas, October 1862,* a selection of the History Book Club and winner of the Tullis Prize from the Texas State Historical Association.

McCaslin earned a bachelor's degree from Delta State in 1982, a master's degree at Louisiana State University and a Ph.D. at the University of Texas. He joined the High Point University faculty in 1990.

# Alumni Mews

## Training like the pros

The DSU aviation program is well known throughout the region. The well-structured program offers stu-

dents the competitive edge they need to land their career on the right path. A recent donation, made by an alumnus of the university, offers students the opportunity to perfect their pre-flight skills of flying a 727 aircraft.

Chuck Booth, a captain and fleet manager of American Airlines, gave the Commercial Aviation Department a 727 procedures trainer. Tommy Sledge, Chair of the Aviation Department says, "Students will use the

trainer to run pre-flight checklists." Sledge says the first few runs can be time consuming and generally take a half hour; however once a pilot works with the trainer the time reduces to five minutes. The actual trainer is made of wood with pictures of the instrument panel. "It is set up just like the cabin of the 727," says Sledge. Running through the checklist helps the student to be familiar with what they will actually encounter if they fly the aircraft. Having the procedures trainer on campus provides students with the same training experiences required

from major airlines. According to Sledge, "When a student can show proficiency based on the opportunities offered during their undergraduate experience, it gives them a leg up on the competition."

Booth graduated from Delta State in 1978. He says his experiences at Delta State led to an exciting aviation career, "Our professors set high standards for us." Booth says those great expectations allowed him to achieve new heights in the U.S. Navy in the Aviation Officer Candidate School program. During his tour of duty, Booth trained and

> checked crewmembers in the simulator and during normal line flights. Those skills took him to American Airlines as a member of their Flight Training Department.

> According to Booth, the newest addition to DSU's Aviation Department was built in the early 1970's and was used by American to train crewmembers during Transition and Recurrent training. It is estimated that eight to ten thousand pilots and flight engineers have been trained on the procedures trainer. "Adding this trainer to our curriculum means


DSU pilots are receiving the same instruction as those already in the workforce."

# **Definition States** Education with a personal touch

All colleges and universities recruit potential students with extravagant brochures, elaborate websites, and catchy TV and radio advertising. Delta State, however, goes beyond the usual marketing techniques and delivers unique services to the students who enroll here.

Loyal alumni always make every effort to educate potential students about unusual services and conditions at DSU, such as the low student/faculty ratio, the small classes which are never taught by graduate assistants, the state of the art physical facilities, the diverse student organizations, and the friendly atmosphere. In addition, however, prospective students need to be aware of certain services that set DSU apart from the conditions found on many campuses.

Former graduates of DSU are high in their praise for their alma mater. "When I got here I didn't anticipate falling in love with it like I did," says Kristi Pantin, who is back for a master's degree. Pantin, who grew up in Texas, recalls being "scared to death of college in general" when she picked Delta State as the place where she would do undergraduate study. Now, when she's not hauling home a pack full of books, she works as a DSU enrollment counselor, helping to recruit students to DSU.

Pantin feels that easy access to faculty members at Delta State has made the learning process less daunting. As a

small regional university, Delta State is the rare sort of place in publish-or-perish higher education where professors, rather than graduate assistants, still teach introductory courses.

Jermaine Ross, a senior math education major from Grenada, voiced a similar appreciation of the personal attention DSU faculty give their students.

Ross, who transferred to Delta State from Holmes Community College, says Delta State's small size helps give it an everyone-knows-everyone-else feel.

That everyday friendliness and supportiveness also flavors the way Delta State offers campus services such as

health care. Nurse-practitioner Bevaline Black, director of the O.W. Reily Health Center, is nearly certain to greet you with a smile and a kind remark, and may hug you if she knows you. Black explains that staff members at the Health Center provide effective care for acute illnesses and minor injuries.

The Health Center offers physicans care five days a week, and nursing care 24 hours a day, seven days a week-the only university clinic in Mississippi to do so. "If a student needs crutches, he or she can simply sign them out rather than having to buy them," Black adds that many university clinics now sell crutches rather than lending them.

Other attractive features of the care offered at the Reily Health Center are that the facility maintains 16 beds for students who may need to remain at the facility and the onsite counseling services available in the same building under the direction of Dr. Richard Houston.

Delta State offers another economi-

cal, premium service on campus: a laundry that cleans around 250 shirts and 200 pairs of pants each day. The cost of this service is included in fees that full-time, dormitory students pay. Thus, students staying on campus need not shell out additional cash to do laundry. In addition to offering quality services, the staff of the laundry demonstrate great school spirit.

"I bleed Delta State green and white," says Nealy Robinson, a 17-year Delta State employee and retired volunteer fireman who has directed laundry services since 1998. Robinson also paints logos and numbers on the university gridiron during football season, and takes pleasure in explaining how the university laundry cares for uniforms and other clothing worn by the school's athletes. He's quick to praise his staff members for their hard work –even in the punishing, humid temperatures of Mississippi Delta summers –and he's impressed by the way they honestly make sure students get back anything they leave in the pockets of the clothes.

More than all of this, though, Robinson is a satisfied customer who keeps a picture in his office of his son, Justin "Fish" Robinson, who was Student Government President several years ago at Delta State and is now in the ministry.

> Delta State's uniqueness has spread beyond the area. Increasingly, the university is host to students from countries around the world – Turkey, South Africa, Nigeria, and the republics of the former Soviet Union, just to name a few.

> Adetokunbo Adedoyin, a math major from Nigeria who plans to become an engineer, is one such student. "Toks," as he is known to friends, says he values Delta State because of its location in a small town. "There are fewer distractions from study here than in large metropolitan areas," he says. Having grown up in an insensitive urban environment, "Toks" observes that Mississippians are quite friendly – so friendly he had to adjust to it.

For some Delta State students, the school's friendly social climate may lead a permanent attachment. Dr. Wayne Blansett, Vice President for Student Affairs, is a good example. A native of Houston, Mississippi, Blansett enrolled at

Delta State in 1969, and is now in his 28th year as an

employee of the university. "I didn't know anything about what to expect," Blansett says, recalling his initial exposure to DSU, "but I

found that friendliness was not just a sales pitch." Today, as an administrator, Blansett says he sees the

university as an institution with distinct missions, among them improving the quality of life for Delta residents and graduating students.

The bottom line, though, is that Delta State University can still offer education at a bargain price with a personal touch.

# **"Doc" Griffin Memorial Scholarship Endowment created**

In 1932, pursuing an education wasn't the problem for William. D. Griffin, the son of a sharecropper; financing was. He never forgot his struggle and to help others earn a college degree, "Doc" Griffin bequeathed Delta State University \$258,000 for the W.D. "Doc" Griffin Memorial Scholarship Endowment Fund. "Doc" was a charter member of the University's planned giving club, *The Quadrangle Oak Society*.

After graduating from Cleveland High School in 1932, Griffin had at least one hurdle to cross before embarking on his higher education at Delta State Teachers Collegepayment. Being the son of a sharecropper, Griffin realized that the cost of a higher education would be a problem. His desire, however, inspired him to go straight to the top.

During a special meeting with then president, Dr. William Kethley, Griffin asked if he and his brothers could be admitted to Delta State. Griffin was upfront telling

Kethley he had the desire, but funds were limited. Kethley replied, "I can't pay bills with desire, but if you join the National Guard and sign your \$17 per month paycheck over to Delta State, I will let you matriculate." Griffin immediately signed up for the National Guard.

Griffin graduated in 1937 and had successful careers in education, the military, and farming. He appreciated the life afforded by his education and wanted to help others. Prior to his death on September 15, 2001, Griffin made provisions in his estate to endow scholarships for needy and deserving students.

"We greatly appreciate the generosity of 'Doc' Griffin in offering this gift," said Dr. David Potter. "His gift will enhance our ability to attract talented students to our campus regardless of their economic circumstances. The success of these students at the University will be a worthy legacy for 'Doc'.

While at Delta State, Griffin was active in the Baptist Student Union and the Delta Singers. He


was a four-year letterman in football, and was inducted into the Delta State Sports Hall of Fame in 1979. Griffin was a Communications Officer for the Bolivar County Civil Defense, a member of the Mississippi Region I Radio Amateur Civil Emergency Service, a scoutmaster for the Boys Scouts, member of the American Society of Composers, Authors and Performers, member of Delta Council, and the American Legion.

As a charter member of the Yale Street Baptist Church in Cleveland, Griffin wrote religious music, including "The Farmer's Prayer", which has been released three times. Royalties from the first release bought the church a bus and proceeds from other songs have benefited St. Jude's Hospital in Memphis.

# **'02 Alumni Coaches Hall of Fame inductees**

Lloyd Clark, Troy Ricks and the late H.D. "Cotton" Robertson were inducted into the 2002 Coaches Hall of Fame.

Lloyd Clark ended a 28-year basketball-coaching career last season as the head women's basketball coach. Clark began his career at Warren Central High School where he posted a 245-42 record in a nine-year span. During the run, Clark guided WCHS to five trips to the State Tournament, seven district championships and five Little Dixie Conference championships. Clark took the helm at DSU in 1983 and continued his coaching success with the Lady Statesmen. Clark earned the NCAA national Championship three times, brought home nine Gulf South Conference championships, 16 appearances in the NCAA tournament and advancing to the Elite Eight and the Final Four 11 times. The Drew native ended his collegiate coaching career with an overall record of 494-156.

Troy Ricks was a veteran basketball coach of 25 years. He coached at Saltillo High School, Copiah-Lincoln Community College, Raymond High School and Hinds Community College. Rick's teams made appearances in the MHSAA High School Playoffs 12 times in his career, while advancing to the state finals seven times. Ricks is credited with five basketball and one football state championships. Ricks has been inducted into the Mississippi Junior College Sports Hall of Fame, Hinds Community College Sports Hall of Fame, Copiah-Lincoln Sports Hall of Fame and the DSU Sports Hall of Fame and finished with a career record of 449-156.

H.D. "Cotton" Robertson is a 34-year coaching veteran, who made his name as the head coach at Durant High School for 20years. Before his untimely death in 1996, Robertson coached at McAdams High School, St. Martin, in Union, Rolling Fork, Pearl, Morton, and Durant. Coach Robertson has two undefeated teams to his credit while at Rolling Fork in 1968-69. At Durant, Robertson's teams won three conference and eight division titles. While at the helm, Robertson guided Durant to a 33 game winning streak, while being named conference Coach of the Year four times. Robertson is also a member of the DSU Sports Hall of Fame and ended his career with a record of 230-123-8.



# **DSU remembers B.F. Smith**



B.F. Smith, long-time chief executive officer of Delta Council, died January 12, 2003 at his home in Leland after a lengthy illness.

Smith was named executive vice president of Delta Council in 1948, and served as the CEO of the Stoneville-based regional economic development and farm organization until 1982.

Smith became recognized throughout Mississippi and the nation for his impact on higher education, health care, flood control, highway developments, and national politics affecting agriculture.

In 1939, Delta State graduate Smith was instrumental in the organization of the DSU Foundation, serving as its initial president. Smith also served the University as president of its Inter-Alumni Council and Alumni Association. In 1964, he was recognized as Delta State's "Outstanding Alumnus."


